### Positions Available

Consider a rewarding career as a professional Financial Institutions Examiner (FIE) with the Department of Financial Protection and Innovation (DFPI).

### Who Should Apply?

Graduates with a four-year bachelor's degree in either:

- Accounting
- Business Administration
- Economics
- Finance
- A related business/management specialization
- Or individuals who have completed a minimum of 16 semester hours of professional accounting courses and three semester hours of business law.

### Competitive Salary

As of July 1, 2020, the starting salary for a Financial Institutions Examiner is approximately \$59,160 annually. Additionally, upon successful completion of the first and second year, you are eligible for a performance raise of 5% and up to 15% respectively.

Effective July 1, 2020, in response to the economic crisis caused by the COVID-19 pandemic, the Department of Human Resources implemented the Personal Leave Program 2020 (PLP 2020). State employees are subject to a 9.23% salary reduction in exchange for 16 hours per month of PLP 2020 leave credits. The annual salary listed above does not reflect the reduction in pay.

### What to Expect

FIEs conduct, plan and direct the appropriate examination programs to provide the State of California with a safe, sound, and efficient financial environment.

In your first year as an FIE, you'll work closely with seasoned examiners in order to learn the examination process. FIEs are responsible for analyzing financial and compliance reports in order to evaluate overall safety and soundness of the financial service institution. FIEs are challenged with new and varying assignments at each examination and operate in a collaborative stimulating work environment.

You will also have the opportunity to work and network with federal regulatory agencies such as:

- Consumer Financial Protection Bureau
- Federal Deposit Insurance Corporation
- Securities and Exchange Commission
- Federal Reserve Bank
- National Credit Union Administration
- U.S. Department of Justice

## Excellent Benefits

The State of California offers many other benefits with employment:

- Health, dental, and vision plans that cover the employee, spouse/registered domestic partner, and dependents
- Pensions managed by the California Public Employees Retirement System (CalPERS)
- FlexElect Program
- Savings Plus 401(k) and 457 deferred compensation plans
- Sick Leave - up to eight hours per month
- Vacation - two to four weeks annually, based upon length of time in state service
- Holidays - 11 state holidays, plus one personal day
- Two days of Personal Development & Training per fiscal year
- Voluntary Personal Leave Program - 1 extra day of vacation for a 5% pay reduction
- Flexible work schedule, including regular day off

## Travel Opportunities

As an FIE, you'll be working in the field at a variety of financial service institutions away from headquarters office. Overnight travel may be required 25% to 75% of the time.

## CPA Opportunities

Although being a Certified Public Accountant (CPA) is not a requirement for an FIE position, assistance may be available to pursue certification. This includes a \$3,600 stipend upon passing the exam.

## Training Program

All FIEs have the opportunity to receive comprehensive training.

## Other Certifications

Additional certifications an FIE can pursue:

- Chartered Financial Analysts (CFA)
- Certified Anti-Money Laundering Specialist (CAMS)
- Five different CSBS Certifications
- RMA Credit Risk Certification

## Hiring Process

1. **Establish Eligibility** - To establish eligibility go to [www.calcareers.ca.gov](http://www.calcareers.ca.gov), review the FIE examination bulletin for details on the examination/assessment and the minimum qualifications required to compete in the examination/assessment. Then, apply, participate, and successfully pass the FIE examination/assessment to get placed on the eligibility list. 2. **Apply for Vacancies** - Once eligibility has been established, search and apply for FIE job opportunities at [www.calcareers.ca.gov](http://www.calcareers.ca.gov) or [www.dfpi.ca.gov/careers](http://www.dfpi.ca.gov/careers). Complete a State Application (STD. 678) and submit the application online or to the address listed on the job opportunity.
3. **Interview** - Hiring interviews are scheduled with the most qualified applicants.
